Re: Request for Letter Documenting Gertrude Gettinger's Current Diagnosis

Dear Dr. Jacob:

As you will recall, on April 3, my attorney requested a letter from you summarizing my mother's (Gertrude Gettinger's) current mental diagnosis. (A copy of my attorney's letter is attached for your reference, although I know it is already on your files.)

To make things easier for you, I have drafted and enclosed a draft letter from you (in layman's terms) outlining the key issues my mother's attorney and my attorney hoped your letter could address, specifically:

- ☐ My mother's current mental diagnosis and condition < This is the real question
- ☐ Her ability to reason logically and make clear, sound judgments, i.e., regarding real estate transactions or other significant legal decisions
- ☐ Her susceptibility to influence and having her mind changed easily by anyone trying to manipulate her by agreeing with her distorted views of reality

My goal is obviously not to put words in your mouth, but rather to **help facilitate the process of getting this letter prepared**, as my mother's continued well-being hinges on your professional opinion in these matters.

My brother is insisting that Gertrude Gettinger is of sound mind and he has actually convinced her to reverse herself on many significant issues pending before the court – and thereby rapidly destroying my ability to continue my efforts to care for her as her conservator. For example,

- ☐ In January, she agreed to selling her decrepit apartment building in Hollywood and felt it was a wise and appropriate decision when I and her attorney (separately) took the time to explain it to her. My brother arrived in March (he hadn't visited her for several years before this) and has convinced her that selling the apartment is a bad idea. (The court approved the sale anyway, since it made so very much sense.)

The Doctor has never met the brother nor has any knowledge or evidence that anything took place.
Sylvia is manipulating and influencing Doctors.

- ☐ For the past year, she told me she liked and trusted her attorney. My brother arrived on the scene and now suddenly she does not like nor trust her attorney. (Her attorney is an individual selected independently by the court who has nothing to do with me.)
- ☐ Before she was placed in a conservatorship, my mother accused me of stealing her belongings, even though I had no access to her apartment. At the same time, she accused me of being tricky and returning to her apartment in the middle of the night to return many of these "stolen" items.

The Hollywood police investigated after she called them repeatedly—and obviously found her unfortunate ranting to be without merit. (This erratic behavior served as the basis for her being placed in the conservatorship.) Recently, my brother contacted the Hollywood police, *demanding* that the case be re-opened, as his mother now insists that I have stolen her property and papers. (The Hollywood police visited me, read her medical records, searched my home, and dismissed their investigation immediately.)

Your help in providing a current expert opinion on her mental well-being and susceptibility to manipulation is greatly appreciated. I would like to get a restraining order issued to prevent my brother from continuing to incite my mother and involve her in his desperate attempts to gain access to her assets. Again, anything you can do is greatly appreciated.

Sylvia has no contact with "brother" yet she makes misleading statements such as the brother convinces mother to not trust her attorney. Sylvia does not inform Doctor that a Police report proves Sylvia is suspected of burglary in Sept 2006. Los Angeles Police did NOT dismiss their investigation. Police re-opened case when Gertrude saw her stolen property at Sylvia's home.

Through out conservatorship Sylvia makes statements which require her to have access or be inside her mothers home to witness events. She states "she has no access".

Sylvia DID have access to a spare key to Gertrude's apartment and has used it so she is a suspect by Police.

Sylvia states goal to get a restraining order against her brother. That he is trying to gain access to her assets. Sylvia has access to 2 million dollars not the brother. Even before brother visited Gertrude, she accused Sylvia of burglary, elder abuse, theft and forming the conservatorship against her will. Sylvia wants people to think all was OK before brother was told about location of mother.

To Whom It May Concern:

Gertrude Gettinger first came under my care when she was admitted to East Valley Medical Center on March 9, 2007.

Ms. Gettinger was admitted to the hospital from the Regency Park assisted living facility after refusing to take her medication. She was not eating and was extremely paranoid and agitated. She had to be restrained during her stay, as she was extremely paranoid and would not let anyone near her. My final diagnosis after observing her for the 5 days she was at East Valley Medical Center indicated Psychosis, not otherwise specified, and Alzheimer disease with behavioral problems.

Ms. Gettinger was discharged from East Valley on March 13, 2007 with a prescription for psychotropic medication and outpatient treatment and followup. Her expected outcome after discharge was determined to be fair if the patient continued to take her medication and if she was cooperative with her treatment.

I resumed psychiatric care and treatment of Ms. Gettinger in July 2007 and have continued to see her approximately every six weeks. Ms. Gettinger at times still continues to refuse to take medications and has made it necessary to supplement her oral medication with injections. Ms. Gettinger continues to suffer from several mental conditions which include dementia with extreme paranoia.

She appeared to be improving when I met with her in January 2008, but during her last visit on April 18, 2008, she was once again extremely paranoid and difficult. My current assessment is... (please complete) < Note told to add info but include Sylvia's info as his

In her current mental state, Ms. Gettinger is not of sound mind and does not have the capacity to reason logically (or continues to be severely impaired in her ability to reason logically). As such, she is not in a condition to make clear, sound and rational judgments.

Ms. Gettinger continues to deny her mental illness. This, combined with her actual current mental confusion, makes her particularly susceptible to manipulation and undue influence by individuals who reinforce and validate her beliefs, delusions and/or paranoia, and agree with her distorted view of reality at any given moment. She is likely to change her mind easily, depending on who she spoke with last and whether that person accepted or rejected her view of her situation.

Why is the conservator writing letters for doctors? Why is she adding events, information that are not verified or proven? Note her statement "Refuses to take Medication(s)". Dr. Jacob has made it clear that Gertrude does NOT have Dementia yet Sylvia wants him to change his assessment. She wants the doctor to state it was HIS idea to inject Haldol.
